What is this product?

Type

Shares of a sub-fund of Fidelity Institutional Liquidity Fund plc, an Undertaking for Collective Investment in Transferable Securities (UCITS).

Term

This fund is open-ended. The Management Company is not entitled to terminate the fund unilaterally, however, the board of directors of Fidelity Institutional Liquidity Fund plc may terminate the fund by way of liquidation or merger.

Objectives

Investment objective The fund aims to maintain capital value and liquidity whilst producing a return to the investor in line with money market rates.

Investment policy The fund invests at least 99.5% in US Treasury obligations (which are money market instruments issued or guaranteed by the US Treasury and payments of principal and interest thereon which are backed by the full faith and credit of the US government), reverse repurchase agreements secured by such instruments and cash (including deposits).

Investment approach Investments will have a credit quality consistent with maintaining Moody's Aaa-mf rating and a rating of AAAM by Standard & Poor's for the fund. Such ratings were solicited by the manager of the fund and financed by either the manager or the fund.

Benchmark N/A. The fund is actively managed without reference to a benchmark.

Distribution policy As this is a non-distributing share class, dividends are re-invested.

Further information You may sell (redeem) or switch some or all of your shares to another fund on any Valuation Day. The fund is a Public Debt Constant Net Asset Value Money Market Fund and operates as a Short-Term Money Market Fund. 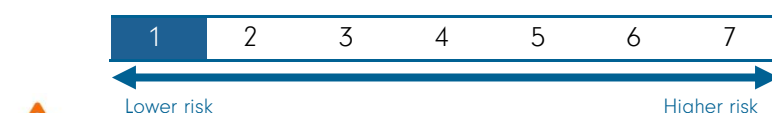

Intended retail investor

What are the risks and what could I get in return?

Risk Indicator



The risk indicator assumes you keep the product for 1 Year.

The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 1 out of 7, which is the lowest risk class. This rates the potential losses from future performance at a very low level, and poor market conditions are very unlikely to impact the capacity to pay you.
