## What is this product?

### Type

Shares of a sub-fund of Fidelity Active SStrategy SICAV, an Undertaking for Collective Investment in Transferable Securities (UCITS).

**SFDR Article 8** (promotes environmental and/or social characteristics) - ESG Tilt.

### Term

This fund is open-ended. The Management Company is not entitled to terminate the fund unilaterally, however, the board of directors of Fidelity Active SStrategy SICAV may terminate the fund by way of liquidation or merger.

### Objectives

**Investment objective** The fund aims to achieve a positive total return up to the fund's scheduled liquidation in 2030.

**Investment policy** The fund invests in a broad range of euro denominated corporate and government bonds from anywhere in the world and with a maturity date similar to the fund's maturity date. During the Initial Subscription Period the fund will allocate investments to money market instruments, other UCITS and UCIs, bonds, cash and cash equivalents. After the Initial Subscription Period, the fund may invest in the following assets according to the percentages indicated:

Perpetual bonds: up to 5%

Investment grade bonds: up to 100%

Below investment grade or unrated bonds: up to 40%, with unrated bonds less than 10%

Hybrids and contingent convertible (CoCo) bonds: less than 15%, with CoCos less than 5%

Emerging markets: up to 15%

Money market instruments: up to 20%

In order to transition the fund to liquidation at maturity, in the 6 months prior to the maturity date, the fund may invest up to 100%

of its assets in money market instruments and/or other short-term bonds including certificates of deposit, commercial paper and floating rate notes, as well as cash and cash equivalents.

At Maturity Date, the fund will be automatically liquidated.

**Investment approach** The fund is actively managed and is not managed with

reference to a benchmark. In actively managing the fund, the Investment Manager uses in-house research and investment capabilities to identify suitable opportunities across bond issuers, sectors, geographies, and security types. This may include an assessment of bond issuers' creditworthiness, macroeconomic factors, and valuations. The Investment Manager considers ESG characteristics when assessing investment risks and opportunities. In determining ESG characteristics, the Investment Manager takes into account ESG ratings provided by Fidelity or external agencies. The fund aims to achieve an ESG score of its portfolio greater than that of the investment universe. Through the investment management process the Investment Manager aims to ensure that investee issuers follow good governance practices. **Distribution policy** As this is a non-distributing share class, dividends are re-invested.

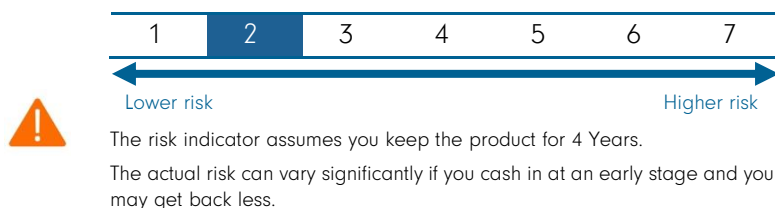

### Intended retail investor

This product may appeal to investors with a basic knowledge of and no or limited experience of investing in funds, who plan to hold their investment for a recommended holding period of at least 4 years, who seek capital growth over the recommended holding period and income; and who understand the risk of losing some or all the capital invested.

## What are the risks and what could I get in return?

### Risk Indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.
